## "EXPOCHESS, THE CROSS CULTURE OF CHESS" I. PAINTING CONTEST

Instituted by the cultural association EXPOCHESS X.E. accordance with the following rules:

- 1. Artists of all nationalities can participate. The theme is chess, technical format will be free and the format will not be more than 1.70cm x 1.70cm. The framework shall not exceed 3 centimeters.
- 2. The artists can participate with only one work. There will be a pre-selection of the works for which participants must go to the following Web page <a href="http://www.expochess.org/en/pages/expochess\_2015/Lakua/contest/2015\_contest.php">http://www.expochess.org/en/pages/expochess\_2015/Lakua/contest/2015\_contest.php</a> and introduce a photograph of the work in digital format (jpg, IPG, tiff ..., high resolution and a maximum of 8MB) and not the original work (physical), that it will be required only to those who have been accepted by the jury to participate in the exhibition and opt for the prize .
- 3. The artists also will give their curriculum, technical specifications of the work (title, dimensions and technique) and an explanatory text on the conceptual framework of the composition. The documentation must be sent before 10 July at the following address: <a href="mailto:info@expochess.org">info@expochess.org</a> specifying the subject for the First International Painting Contest "EXPOCHESS LAKUA".
- 4. Shall be communicated to all the participants the selection or not of his work by the jury via the website before 15 July; the selected will be contacted personally. The selected works will be delivered personally or sent by transport agency, properly mounted for display in the **GRAN HOTEL LAKUA** \*\*\*\*\*\*, **Calle Tarragona**, 8 **01010 Vitoria**, **Spain**, **10 to 14 hours**, **from 15 to 21 July**. The shipping and return cost of the works shall be borne by the participants; the organization is not responsible for the damage that could suffer works.
- 5. Will not be admitted more than one work by the same author, nor will any that has obtained any prize in other competition.
- 6. The works selected by the jury will be exposed at the **GRAN HOTEL LAKUA**, from 23 July to 16 August 2015. The jury's decision will be final, will be announced at the opening of the exhibition.
- 7. A single prize of **1200** euro (of which the legally established tax is deducted) is established. The jury, if it deems it appropriate, may grant one or several honorable mentions (no monetary prize). A reproduction of the winning work may be appear on the front of the stage for the next contest; on the back they will be reproduced the works that have earned honorable mention \*. The winning work will become the property of the cultural association EXPOCHESS X. E. and will become part of its artistic heritage.
